DISTRIBUTION SERVICE CIRCULAR NO.1/2019

~Implementation of New Connection Charges Guidelines 2019

Please be informed that Majlis Mesyuarat Kerajaan Negeri (MMKN) at its meeting on the 24th January 2019 has endorsed the implementation of the revised New SESCO's Connection Charges Guidelines (CCG) 2019 to be effective 1st March 2019.

As stated in Ministry of Utilities Sarawak letter ref: R/KUS/MMKN/G dated 28th February 2019, the New SESCO's Connection Charges Guidelines 2019 aims:

- i. To support Government-assisted housing scheme;
- ii. Clarity in connection charges policy;
- iii. Fair connection charges; and
- iv. Improved application processes.

Hence, the new Connection Charges Guidelines 2019 shall supercede the Connection Charges Guidelines 2008 Revision 2.

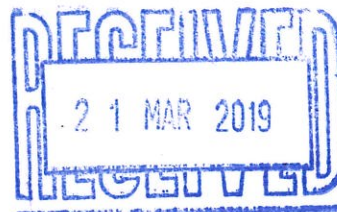
